

FACTS**WHAT DOES ROADRUNNER FINANCIAL, INC. ("RRF") DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number, income and contact information
- account balances, payment history and transaction history
- vehicle information and credit information

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons RRF chooses to share; and whether you can limit this sharing.

What we do	
How does RRF protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does RRF collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> • give us your contact information • apply for financing or apply for a loan • pay your bills or provide account information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes — information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • Our affiliates include financial companies such as Roadrunner Account Services, LLC and Octane Lending, Inc.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • Nonaffiliates we share with can include other financial companies and original equipment manufacturers.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> • Our joint marketing partners may include dealerships with which we have a business relationship, other financial companies and original equipment manufacturers.

<p>California and Vermont Residents: We will not share your information with companies outside of RRF and its affiliates, except for our everyday business purposes, for marketing our products and services to you, or as required or permitted by law or with your consent.</p> <p>Texas Residents: RRF is licensed and examined under the laws of the State of Texas and by state law is subject to regulatory oversight by the Office of Consumer Credit Commissioner.
